All approved signs posted in a studio or on the premises shall be considered a part of the Policies and Rules of Studio 3MI.

## **Membership Fees**

- a. Membership

  - ii. 12 Month Option of \$200.00 or 360.00 billed every 365 days

Membership fees are nonrefundable. We may change the Membership fees at any time.

## Term; Automatic Renewal; Billing

Automatic Renewal Membership fees will be billed as stated above to the credit or debit card you provided we currently have on file for you, in the amount of the then current Membership fee via paypal subscription.

# **Membership Cancellation; Termination**

- a. Once a Membership is established, it is the member's responsibility for dues shall be continued until such time that Studio 3MI receives an email and payment for any outstanding balance. Until we receive notice of membership cancellation, members remain responsible for all dues.

- c. We may terminate your Membership, including any associated accounts, without notice, for any reason in our sole discretion including without limitation our belief that continued use of such Membership would violate any provisions of this Agreement, applicable law, or otherwise be harmful to our interests. In the event of any such termination, you will not be entitled to a refund of your membership fee.

d. If a Member has an outstanding balance on their account without a cancellation notice, the member will not be able to book the studio until all dues are paid. Nonuse of the facility does not constitute a membership cancellation for relieve the member of the responsibility for paying accumulating dues.

#### **Event Rates**

Vary based on a variety of factors including type, size, food, space, & more. Please contact josh@3miphotography.com for a custom quote.

- a. Bookings that are extended after 11:30PM are charged at double the normal rate.
- b. Payment in full is required when reserving the studio.
- c. Studio 3MI does not accept checks, money orders
- d. Studio 3MI will make every effort to be open during inclement weather. If we are unable to open the studio due to weather, we will credit your account and apply it to a rescheduled booking. If the studio is open and you cannot make it to the studio for your shoot, notify the studio with at least twelve (12) hours prior to the start of your booking; credit amount will be determined at that time.
- e. Once you receive your booking confirmation, you are required to pay for your entire booked time, regardless if you end your shoot early, arrive late, don't show up at all, or if your model/client/subject does not show up.
- f. Your booking should include set up, break down, and clean up time. This includes but is not limited to setting up lights, makeup/hair prep, packing up, returning props, and check out. If you or anyone else involved in your shoot is occupying the studio area you will be charged for it.

g. If the studio is available, you may enter the studio no sooner than 15 minutes before your scheduled shoot time.

# You will be charged for that time in addition to your initially booked time, even if you end early.

- h. We will make every effort to accommodate shoots that run over the booked time. If no one has booked the studio after you, you may extend your time in the studio. You will be charged at the normal studio rental rate. You are not guaranteed overtime, so you should make every effort to finish your shoot during your booked time. Over time is at the staff's discretion.
- i. Studio time is prorated in 30 minute intervals, rounded up.
- j. Members are guaranteed 2 Godox VL300, 3 Godox SL 150, 2 Godox SL 60, Various Soft boxes for every shoot. Additional equipment is provided on a first come first served basis.
- k. Studio 3MI reserves the right to change the rental rates at any time.
- I. Studio 3MI reserves the right to increase rental fees for events. What constitutes an event is at our discretion.

# **Booking Cancellations**

Cancellation Times are from the Start Time of the Booking. Percentages are based on the total amount of booking.

30+ Days Notice 100% Credit to account

48 hours - 29 Days Notice 50% Credit to account

Within 48 hours Notice Full Payment is Due, No Credit.

#### Studio Rules – ADDITIONAL FEES MAY APPLY FOR FAILURE TO FOLLOW RULES

### 1. NO GLITTER, FAKE BLOOD, PAINT, OIL OR ANY OTHER MESSY ITEMS

- 2. Food and beverages are permitted within the studios, please be respectful, dump out liquids in sink and all food items in the main studio ( brown ) trash can also advise staff there is food items.
- 3. Do not stand, run, sit, etc. on the curve of the cyc wall. It is hollow and will not support weight. NO HEELS ON FURNITURE
- 4. Clients are responsible for all damages caused during the rental. These charges are at the discretion of Studio 3MI.
- 5. Clean up fees may be applied if the studio is left in an overly messy state. This is at the staff's discretion.
- Props including furniture may be used. Please ask staff for assistance moving furniture onto and off of the cyc wall, if necessary. You are expected to leave the studio as you found it.
- 7. Do not enter studio spaces without permission from staff. Studio 3MI staff may enter any part of the studio at any time.
- 8. ANIMALS: Must have written consent from Studio 3MI. All animals must have a handler at all times. The handler must have this as their sole position for the shoot.
- 9. MINORS: Persons under the age of 18 must have a parent/guardian with them at all times.
- 10. MESSY SHOOTS: Any shoot that may become "messy" including but not limited to Oil, Water, Mud, Food, Snow, etc must be approved with Studio 3MI.
- 11. Studio furniture and props are available on a first come first serve basis.
- 12. Car shoots will require a \$100.00 refundable deposit and MUST be approved ahead of time. Any mess made will either require a cleaning fee or cleaned by renter to staffs satisfaction.
- 13. First time Clients will be required to receive a short orientation to the studio and the equipment
- 14. RAINSET No shoes that are not approved by staff, no objects other than the model, without approval DAMAGE OF RAIN SET WILL RESULT IN FEE
